THE FAMILY & YOUTH CENTER (FYC) FOSTERS STRONGER INDIVIDUALS AND FAMILIES IN AN OVERWHELMINGLY MINORITY COMMUNITY THAT HISTORICALLY HAS BEEN UNDER RESOURCED AND ECONOMICALLY CHALLENGED. IN ADDITION TO SUPPORTING STRONGER FAMILIES (AND THEREBY COMMUNITIES), A KEY AIM IS TO PREVENT HOMELESSNESS AMONG MEMBERS OF THIS COMMUNITY LATER IN LIFE. THE FYC HELPED 6,266 FAMILIES (21,374 PEOPLE). 6,231 FOOD BASKETS WERE DISTRIBUTED, 10,199 ARTICLES OF CLOTHING, AND 9,849 MEALS WERE SERVED. PROGRAMS INCLUDE SUMMER LITERACY, TUTORING, AFTER SCHOOL ACTIVITIES, FOOD DISTRIBUTION, CONTINUING EDUCATION, FAITH BUILDING, CAMPS, RETREATS AND MORE.

THE MEN'S NEW CREATION RECOVERY PROGRAM IS A RESIDENTIAL PROGRAM THAT USES A CHRISTIAN, BIBLICALLY BASED METHODOLOGY TO HELP HOMELESS/AT-RISK MEN OVERCOME TRAUMA, ADDICTIONS, AND OTHER ISSUES SO THEY CAN BE INDEPENDENT, HEALTHY, AND PRODUCTIVE MEMBERS OF SOCIETY. THIS 12-MONTH PROGRAM EMPLOYS INTENSIVE COUNSELING, LIFE SKILLS CLASSES, BIBLE STUDIES, WORK THERAPY AND RECREATION TO FOSTER FULL RECOVERY. THE PROGRAM SERVED OVER 67 MEN IN VARYING STAGES OF RECOVERY, PROVIDING 3,453 COUNSELING SESSIONS, 21 COMPLETED THE PROGRAM AND 37 BECAME EMPLOYED.
JOB READINESS IS A KEY FEATURE OF THE RECOVERY PROGRAMS. PARTICIPANTS HONE WORK ETHICS SKILLS AND ASSIST WITH THE MISSION'S SOCIAL ENTERPRISE PROGRAM, BEELOVED TRADING, WHICH PRODUCES VARIOUS SALEABLE PRODUCTS
