THE FAMILY & YOUTH CENTER (FYC) FOSTERS STRONGER INDIVIDUALS AND FAMILIES IN AN OVERWHELMINGLY MINORITY COMMUNITY THAT HISTORICALLY HAS BEEN UNDER RESOURCED AND ECONOMICALLY CHALLENGED. IN ADDITION TO SUPPORTING STRONGER FAMILIES (AND THEREBY COMMUNITIES), A KEY AIM IS TO PREVENT HOMELESSNESS AMONG MEMBERS OF THIS COMMUNITY LATER IN LIFE. THE FYC HELPED 6,708 FAMILIES (22,929 PEOPLE). 7,558 FOOD BASKETS WERE DISTRIBUTED, 2,216 ARTICLES OF CLOTHING, AND 5,375 MEALS WERE SERVED. THIS 12-MONTH PROGRAM EMPLOYS INTENSIVE COUNSELING, LIFE SKILLS CLASSES, BIBLE STUDIES, WORK THERAPY AND RECREATION TO FOSTER FULL RECOVERY.
